AGENCY RETAINER

\$10,000 Payable in full immediately upon contracting with Fertility Alternatives, Inc.

\$4000 Parental Establishment Fee. (After surrogate has become pregnant and Legal Parental Establishment has been finalized.)

INTERNATIONAL CLIENTS

\$1000 (Administrative fee)

THIRD-PARTY ADMINISTRATIVE FEE

\$250 for additional expense incurred for clients who require their Surrogate to be monitored in one city and Embryo transfer in another.

SURROGATE'S COMPENSATION

\$23,000+ (Depending on needed ethnic background, experience, industry standard of compensation, and the request of the individual surrogate. Many repeat Surrogates will request a fee of higher than \$30,000 plus expenses)

COMPENSATION FOR MULTIPLES

This compensation provides for additional expenses and discomfort resulting from a multiple pregnancy.

\$7000 for twins or

\$8000 for triplets

INVASIVE PROCEDURES COMPENSATION

\$500 for each procedure. (i.e. Termination, selective reduction, amniocentesis, cerclage, etc.)

\$3,000 for c-section for an additional recovery period and includes post delivery assistance.

\$5,000+ if Surrogate should permanently lose any part of her reproductive system as a result of the Surrogate pregnancy. (This is very rare)

EMBRYO TRANSFER FEE

\$1000 per transfer.(includes childcare and lost wages for bed rest.)

NON-ACCOUNTABLE, MONTHLY EXPENSE ALLOWANCE

\$3600+*

*\$300 per month for approximately 12-18+ months for any expenses related to the surrogacy, effective the month following a signed Surrogate Agreement.

(Example: over-the-counter medications, creams, local phone calls, local travel, etc.)

MATERNITY CLOTHING ALLOWANCE

\$800 Payable during the fourth month of pregnancy. +\$200 for multiple pregnancy.

DOCTOR ORDERED BEDREST

Childcare only: \$250 per week

Lost Wages only: up to \$375 per week

PSYCHOLOGICAL SUPPORT

\$1800*

*\$100- per month for 13-18+ months for, travel, meals, and childcare while surrogate attends psychological counseling or surrogate support group meetings.

This does not include the psychologist's fee which may be \$100-\$150 per meeting.

Repeat surrogates may not need or choose psychological support.

MEDICAL INSURANCE FOR SURROGATE

Surrogate Maternity Plan if Surrogate does not already have a policy covering a surrogate pregnancy.

\$12,000 premium approx plus deductible at discounted pricing.

Deductibles: (\$15000-\$25000 for singleton/\$30000-\$37500 Twins only).

A primary policy for pregnancy and childbirth. Other or additional insurance may be available.

Coverage up to \$500,000.

\$27,000-\$49,500 For full insurance

Or

\$5100 for Pregnancy complication insurance only. You will still be responsible for the costs of a normal pregnancy and birth. (\$4500 C-Section deductible if procedure is necessary.)

Newborns will be covered by your insurance carrier.

International clients may have purchase an additional policy for newborns.

TERM LIFE INSURANCE POLICY

\$300-\$400

The cost of a term life insurance policy of \$300,000+ payable to the surrogate's family.

PROFESSIONAL FEES

Psychological Fees

up to \$1000 For screening the Surrogate and her partner.

up to \$800 For screening the Intended Parents.(Psychological screening is required if they have not already undergone some type of screening or counseling. Proof required

\$3600 Surrogate Support Group Meetings (up to \$200 per month for 15-18 months)

Surrogate and Partner Medical Screening Fees

Up to \$3000 For doctor's fees and labs. May vary depending on your chosen physician, and lab used. You will pay the medical facility directly.

LEGAL FEES

\$5,000 Approx

Amount depends on chosen attorney for surrogate and Intended Parents. This fee covers representation for both Parties, and the Petition for Parentage by the Intended Parents' Attorney in order for the Intended Parents to be deemed the legal Parents, before the child(ren) are born.

ESCROW/TRUST ACCOUNT:

Up to \$1000 to Allison-McCloskey Escrow Company to hold the surrogacy funds. Escrow account must be fully funded before Surrogate begins her medical protocol.

(If you are unable to fully fund the Escrow account when open, please let me know, so we can work out an alternative.)

BACKGROUND CHECK and/or CRIMINAL RECORD CHECK(Optional)

\$150-\$600 A basic search for one county is the lower fee.

Additional fees for other available services.

TOTAL: \$105,000+ for normal pregnancy and birth. Fertility Alternatives will do everything possible to keep fees and expenses reasonable.

ADDITIONAL/ OTHER EXPENSES INFERTILITY SPECIALIST FEES:

\$15,000-\$20000+ This fee will vary depending on your chosen specialist, whether the couple carries insurance that covers infertility or surrogacy, and the number of attempt needed to obtain a pregnancy.

MEDICATIONS:

\$3000 Approximately. Per cycle.

ADDITIONAL EXPENSES

Intended Parents will be responsible for all fees incurred by the surrogate mother on behalf of the surrogacy arrangement including the Surrogate medical and psychological screening as well as medications, medical insurance co-payments or deductibles, medical, hospital facility, mental health, attorney's fees, escrow/trust account, and possibly medical or disability insurance.

Other expenses may arise such as, Surrogate's lost wages for bedrest, long distance phone calls, maternity leave, childcare, house cleaning, excessive travel, etc. Each surrogate has her own individual circumstances which may result in additional expense to the Intended Parents. The final result will be determined by negotiations by all parties, their attorneys, and Fertility Alternatives, Inc.

Professionals actual fees may be higher or lower than the amounts stated above. Actual cost can be determined by contacting the professionals directly.

Many variables such as the length of time needed in order for the surrogate to become pregnant, the number of fetuses she may carry, the number of procedures administered, the Surrogate's individual requests and circumstances, the industry standard of compensation, and each individual professional fee, may drastically change the financial outcome originally anticipated in a Surrogacy arrangement. This fee schedule can only give you a better idea of what to expect.
